

REFUSE COLLECTION AGREEMENT

The Owners of Lots 78, 79 and 80 of Tract 817 Phase 3, Lennar Fresno Inc. and the City of Lemoore in order to allow construction of new homes on Lots 79 and 80 while maintaining proper safety procedures for Refuse Collection agree as follows:

The Owners of Lots 79 and 80 agree to place their City Refuse Containers next to the designated location for Lot 78 at scheduled pick up times and remove them after pick up. The Owners further agree to cooperate with all City requests regarding Refuse Collection.


The owners of Lot 78 agree to allow the City Refuse Containers from Lots 79 and 80 to be placed next to their designated location at scheduled pick up times and cooperate with all City requests regarding Refuse Collection.

The City of Lemoore agrees to allow the construction of new homes on Lots 79 and 80 and collect the Refuse for Lots 79 and 80 next to the designated location for Lot 78 at scheduled pick up times.




