**Subject: Bid Award - 2012 18th Ave & 19th Ave Overlay Project /
Co-operative Agreement - Kings County**

Discussion:

Staff opened bids with Quad Knopf in attendance for the City of Lemoore and Kings County 2012 18th Avenue and 19th Avenue Overlay Project on Tuesday, July 31, 2012. This project includes City and County roadway on 18th Avenue from south of Highway 198 interchange to Jackson Avenue and 19th Avenue from Iona Avenue south to Idaho Avenue.

A Cooperative Agreement was formed between the City of Lemoore and County of Kings for cost savings and efficiency. The Kings County Board of Supervisors approved the attached document at their July 24, 2012 Board Meeting noting an estimated cost share of \$695,535. The Kings County's portion is less than was originally estimated. We are requesting City Council approve the Cooperative Agreement (Attachment A).

From the bids received, we are recommending Granite Construction in the amount of \$913,594 for this project. The County of Kings cost share is \$ 498,486.87 leaving the City's cost share at \$415,107.13. The bidders and bids amounts are shown as follows:

Budget Impact:

The City's share of this project will be funded from two fund accounts in 2011-2013 Capital Improvement Budget. Projects 4731A-4317 and 4733A-4317 will be funded with \$415,107.13 from the 031 Gas Tax Section 2107 and 030 Gas Tax Section 2106. The CIP Budget allocated \$500,000 in construction for the project.

Recommendation:

That the City Council, by motion, approve the Cooperative Agreement between the City of Lemoore and County of Kings; award the bid to Granite Construction for the 2012 18th Avenue and 19th Avenue Overlay Project in the amount of \$913,594.00 of which \$415,107.13 is the City's portion and authorize City Manager to sign the County of Kings Agreement and construction agreement and contracts.
