

**RESOLUTION NO. 2012-06**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEMOORE  
DECLARING ITS INTENT TO ADOPT A MERGER ORDINANCE**

At a Regular Meeting of the City Council of the City of Lemoore duly called and held on February 21, 2012 at 7:30 p.m., it was moved by Council Member \_\_\_\_\_, seconded by Council Member \_\_\_\_\_ and carried that the following Resolution be adopted:

**WHEREAS**, §66451.10, et seq., of the California Government Code establishes the authority and basis for the merger of parcels; and

**WHEREAS**, §66451.21 requires the City to adopt a Resolution of Intent to Adopt a Merger Ordinance prior to adoption of the Ordinance; and

**WHEREAS**, on January 23, 2012, the Planning Commission held a public hearing to review and consider the draft Merger Ordinance (to be located in Title 8-7E of the Lemoore Municipal Code) and consider all of the information presented by staff and public testimony presented in writing and at the meeting and voted 7-0 to adopt Resolution 2012-03, making recommendation to the City Council to adopt the proposed Merger Ordinance; and

**WHEREAS**, on February 21, 2012, the City Council held a public hearing to review and consider the draft Merger Ordinance (to be located in Title 8-7E of the Lemoore Municipal Code) and consider all of the information presented by staff and public testimony presented in writing and at the meeting;

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Lemoore hereby declares its intent to adopt the Merger Ordinance (Title 8-7E), subject to a public hearing on April 3<sup>rd</sup>, 2012 at 7:30 p.m. in the Lemoore Council Chamber located at 429 'C' Street in Lemoore, California.
