Subject: Resolution 2012-19 - Intention to Annex and Include
Additional Territories in Zone 5 of Public Facilities
Maintenance District No. 1 in the City of Lemoore and Levy
and Collect Annual Assessments in such Annexed Territory for
Fiscal Year 2012-2013 and Thereafter

Discussion:

The City of Lemoore formed the Public Facilities Maintenance District No. 1 (PFMD) on August 15, 2006 by adoption of Resolution 2006-37. The resolution before Council is to begin the process to annex Tract 791 (East Village/Aniston Place) and create Zone 5 of the PFMD No. 1. The City Engineer has prepared and filed with the City Clerk a report entitled "Engineer's Report and Assessment for Tract 791, Public Facilities Maintenance District No. 1, Zone 5" (attached). Said report contains a description of the existing facilities and improvements, the boundaries of the PFMD and any zones therein, including the boundaries of the territories proposed to be annexed to the PFMD in these proceedings, the facilities and improvements proposed for Zone 5, and the general location and proposed assessments on the assessable lots and parcels of land within the Added Territories of PFMD No. 1.

The proposed assessment per lot is \$1,273.80 per year or \$106.15 per month.

The attached Resolution of Intention will preliminarily approve the Engineer's Report and set the required public hearing on the proposed annexation and assessment of the Added Territories for Tuesday, July 17, 2012. Notice of the public hearing will be published 10 days before the hearing and sent by mail, at least 45 days before the hearing, to the owners of lots and parcels in the Added Territories, along with a ballot for them to vote for or against the annexation and assessment.

In order for the annexation to be approved and the assessments levied on the lots in the Added Territories, the majority of the ballots submitted by property owners within the boundary of the Added Territories must consent to the annexation and levy of the assessment. Votes will be tabulated after close of the public hearing on July 17, 2012.

Budget Impact:

The proposed total assessment for Zone 5 is \$103,177.80 for 2012-2013 Tax Year. Payments are made through the County Assessor property tax roll; first installment would be in December 2012 with the second installment paid in April 2013.

Recommendation:

Council, by motion, adopt Resolution 2012-19 declaring the Intention to (i) Annex and Include Additional Territories in Public Facilities Maintenance District No. 1 in the City of Lemoore, and (ii) Levy and Collect Annual Assessments in such Annexed Territory for Fiscal Year 2012-2013 and Thereafter.
