**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEMOORE AUTHORIZING
THE CITY OF LEMOORE TO APPLY FOR AND ADMINISTER
A SAN JOAQUIN VALLEY AIR POLLUTION CONTROL DISTRICT
CORDLESS ZERO-EMISSION COMMERCIAL LAWN AND GARDEN EQUIPMENT
DEMONSTRATION PROGRAM**

At a Regular Meeting of the City Council of the City of Lemoore duly called and held on September 4, 2012 at 7:30 p.m. on said day, it was moved by Council Member _____, seconded by Council Member _____ and carried that the following Resolution be adopted:

WHEREAS, the City Council of the City of Lemoore supports eco-friendly equipment and operations; and

WHEREAS, the San Joaquin Valley Air Pollution Control District is offering a Cordless Zero-Emission Commercial Lawn and Garden Equipment Demonstration Program “Program”; and

WHEREAS, if accepted, the “Program” provides a maximum of 10 items and at a maximum of \$10,000.00 cost with 10% down payment which is reimbursed upon completion of demonstration period (May 30, 2013); and

WHEREAS, the City of Lemoore is capable of providing the ten percent (10%) reimbursable down payment; and

WHEREAS, the grant application procedures require an Applicant’s governing body to authorize by resolution its approval for submittal of the “Program” grant application and to designate by job title an individual for execution of all “Program” grant documents on behalf of the City of Lemoore; and

NOW THEREFORE, BE IT RESOLVED that the City Council of the City of Lemoore authorizes the City of Lemoore to apply for the “Cordless Zero-Emission Commercial Lawn and Garden Equipment Demonstration Program and does hereby name the City Manager as the signing authority for the “Program” application and administration.
