

RESOLUTION NO. 2013-19

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LEMOORE AUTHORIZING APPLICATION TO THE STATE OF CALIFORNIA
FOR THE NEW KINGS COUNTY ENTERPRISE ZONE TARGETED
EMPLOYMENT AREA**

WHEREAS, the County of Kings and the cities of Corcoran, Hanford, Lemoore and Avenal have separately and jointly taken significant steps to coordinate economic development efforts to generate long-term private sector employment and investment opportunities; and

WHEREAS, the County of Kings and the cities of Corcoran, Hanford, and Lemoore have worked cooperatively in marketing and managing the Kings County Enterprise Zone over the past 20 years as a single labor market area without regard to jurisdictional boundaries; and

WHEREAS, on June 22, 2008, the second Kings County Enterprise Zone became effective; and

WHEREAS, state designated Enterprise Zones can define a Targeted Employment Area (TEA) as one of several criteria to identify residents most in need of employment assistance; and

WHEREAS, a TEA was identified for the 2008 Kings County Enterprise Zone at designation; and

WHEREAS, the statutes governing the Enterprise Zone Program require that each zone update its Targeted Employment Area (TEA) within 180 days of new census data becoming available; and

WHEREAS, the TEA previously approved under the second Kings County Enterprise Zone will be updated with an effective date of January 1, 2013 through this resolution.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. Census tracts 2, 4.05, 5, 8, 9, 10.02, 11, 13, 14.01, 14.02, 15, 16.01, 17.01, all of which are located within the territorial jurisdiction of the County of Kings, have been shown by the 2010 decennial national census to contain at least 51 percent of their residents at or below low and moderate income levels relative to the 2010 County of Kings Median Household Income Levels; and

2. An updated Targeted Employment Area comprised of the above-specified census tracts and having the boundaries as shown on Exhibit A, attached hereto and incorporated herein, is hereby submitted to the State of California Housing and Community Development Department for consideration of designation as Kings County's Enterprise Zone Targeted Employment Area effective January 1, 2013.
