Subject: Notice of Completion – 2014 Resurfacing Project

Proposed Motion:

City Council approve the filing of the Notice of Completion for the 2014 Resurfacing Project, authorize the City Manager to sign and file the Notice of Completion with the County of Kings.

Subject/Discussion:

On February 17, 2015, the Lemoore City Council awarded the 2014 Resurfacing Project to Cen-Cal Paving in the amount of \$679,033. The work was done on the following streets:

- Club Drive – Lemoore Avenue to Murphy Drive
- Cinnamon Drive – Lemoore Avenue to Venice Avenue
- G Street – Hill Street to Fox Street
- Larish Street – Champion Street to Lemoore Avenue
- Cinnamon Drive – Venice Avenue to Balboa Avenue
- Fox Street – G Street to Cinnamon Drive
- Intersection of Hamlet Street and Skaggs Street – Valley Gutter and ADA Ramps
- Intersection of Hamlet Street and Toomey Street – Valley Gutter and ADA Ramps

On August 7, 2015, Cen-Cal paving completed the project in the amount of \$634,430.

Cen-Cal Paving, Inc. is requesting a notice of completion be filed and retention payments released. The release of the retention will be made 35 days after the filing of the Notice and Completion and successful release of any liens incurred on the project.

Financial Consideration(s):

The 2014 Resurfacing Project was funded out of the 2013-15 CIP Budget Fund Number (034). There was a cost savings of \$44,603.
