MINUTES

CALL TO ORDER:

Commissioner Harper called the meeting to order at 7:00 pm.

COMMISSION MEMBERS PRESENT:

Commissioners: Braaten, Harper, Hernandez, Yaeger and Director Simonson and Secretary Taylor

APPROVAL OF MINUTES:

Commissioner Yaeger moved to approve the minutes of March 9, 2010 meeting. It was seconded by Commissioner Braaten. All commissioners voted to approve.

PUBLIC COMMENT:

Community member Nita Painter asked the Commission to look into space for a community garden. Pedersen Playground and Heritage Park were possible locations.

DISCUSSION:

Parents of BMX bicycle riders asked if the Commission would consider granting time for bicycle use at the Skate Park. Commissioners went over concerns about the damage that pegs could do to the Skate Park and the liability issues that could occur. Commissioners and parents both decided to pursue organizing a committee to reopen the BMX track. If that was not possible further investigation would have to be done concerning BMX use at the Skate Park

Joe Simonson went over participation levels in all Recreation Programs.

Lemoore Chamber of Commerce CEO Maureen Azevedo discussed plans for next years Pizza Festival.

UPDATE:

Recreation Coordinator Eric Ferreria updated the Commission on the Corn Maze which is scheduled to open before Halloween.

Director Simonson went over the projects that were submitted for the Proposition 40 grants.

Secretary Taylor updated the Commission on programs and events.

Director Simonson informed the Commission that beginning July 1, 2010 the hours for the Recreation Department would be 10 am to 7 pm Monday through Thursday and 8 am to 5 pm on Friday.
