MINUTES

CALL TO ORDER:

Commissioner Lehn called the Session to order at 7:02 pm.

COMMISSION MEMBERS PRESENT:

Commissioners: Fuller, Lehn, Smith, Sandall, McGhuey, Escalera and Director Simonson.

APPROVAL OF MINUTES:

It was moved by Commissioner Smith and Seconded by Commissioner McGhuey to approve the minutes from September 11, 2012.

PUBLIC COMMENTS:

John Pal commented on the common park located on Fallenleaf that is part of an LLMD District.

INTRODUCTION:

Robert Escalera was introduced as a new Parks and Recreation Commissioner

DISCUSSION:

Mayor Willard Rodarmel gave the Commission information on an indoor Air Rifle Range for the Recreation Center and informed the Commission that grants were available. Lt. Commander Richard Lehn also provided information on Air Rifle Ranges.
