CALL TO ORDER:

Commissioner Fuller called the first session to order at 5:36 pm

COMMISSION MEMBERS PRESENT:

PUBLIC COMMENTS:

At the 5:30 session around 45 citizens took a tour of the undeveloped areas of the Lemoore Recreation Center. The Commissioners spoke with the citizens on the tour as well as the citizens using the Recreation Center that evening regarding how they would like to see the areas developed and what else was needed at the Recreation Center. Crossfit and owner Ryan Rocha were in attendance with 25 members. Mr. Rocha is interested in becoming an instructor for the Recreation Department and offering Crossfit classes at various times during the day. Other ideas included another indoor playground, volleyball courts, batting cages, a waiting area with televisions, a concession stand, a weight room and a swimming pool. Melanie Tatco spoke to the Commissioners about her interest in starting Senior Zumba Classes.

Each Commission took notes on their discussions with the public and will discuss the information at their next scheduled Parks and Recreation Commission meeting that will be held at 7:00 pm on February 12, 2013.
