Members of the Commission:

Thank you for the opportunity to comment in support of Home Occupation Permit No. 2014-23. Since 2003, I have personally relied on Connie Wlaschin to provide professional and skilled tailoring and alteration services and have regularly recommended her to others.

Ms. Wlaschin was referred to me by the tailors at Naval Air Station Lemoore, recommending her as the area's best, to whom they routinely refer military personnel, particularly in advance of military social events. During these periods, several times each year, the base tailors are unable to meet demand, often citing three to four week wait times for routine services. Ms. Wlaschin provides an important service, being regularly able to complete tailoring and alteration services in a matter of days, and sometimes hours, at a reasonable, affordable cost.

Earlier this year, when I moved back to the area and joined a local command preparing rapidly for deployment the following week, the base tailors were unable to fulfill the order on my initial uniform due to an extended backlog. When I sought out Ms. Wlaschin, she was able to complete service on all uniforms within 48 hours at a fair rate.

I respectfully ask that Ms. Wlaschin's request be considered in context of how much her work is relied upon locally and the impact of any loss or disruption in the valued services she provides.
