## BACKGROUND:

The summer months were busy for the recreation department. A variety of different programs and special events were completed. The department meetings were equally productive with three main themes emerging. The staff recognized the need for program supervision realignment, work plan development, and building a more comprehensive 2017 recreation guide.

The realignment discussions started in July 2016 and were implemented after the conclusion of summer programming with support of all Community Services Staff. The changes will occur during the Fall 2016 season, with continuous evaluation of program operations. Once the trial and evaluation phase is complete, full implementation of new programming responsibilities will begin January 2017. The purpose for the realignment is to balance program responsibilities and workloads of the staff in order to offer more programming in 2017.

The new programing areas of responsibilities are as follows:

- Program duties for Recreation Coordinator Sheila Taylor include youth enrichment, adult enrichment, seniors and art.
- Program duties for Recreation Coordinator Juan Cuevas include youth sports, adult sports and aquatics.
- Program duties for Recreation Specialist Jordan Barba include front office, tiny tots, contracts, fitness and rentals.
- Program duties for Recreation Assistant Santos Maya include front office, teens, vending machines, park signs and facility set up.
- All professional staff will be assigned to special events with Mrs. Taylor and Mr. Cuevas taking the majority of the special event responsibility. Recreation staff will still assist each other with programs when there is a large event within a program, such as flag football draft day.

The work plan assignments were issued to the recreational staff in August of 2016. Work plan assignments are new to the staff, and education and training was completed with the understanding that continued staff development would be required. The work plan is initiated at the time new programming is identified and for programs already developed. The work plan is necessary in order to build a more comprehensive recreation guide and to assess the financial feasibility of programs based on concrete data, such as revenue and participation numbers. Work plans also include the program title, description, ages/demographics, location, instructor, min/ max participation numbers, and dates program offered.

The traditional recreation programs will be back in 2017, along with several new program proposals. To date, recreation staff has proposed a total of 34 new programs for the 2017 season. The large increase in programs offered has necessitated the increased use of the Cinnamon Municipal Complex. Finally, in November 2016, the comprehensive recreation guide will go to print and should be ready for distribution in December 2016.

## BACKGROUND:

The Recreation Department inherited Evening Under the Stars in 2010 from the Lemoore Downtown Merchants. Department staff thought it was a nice community event and could use the funds raised for the youth recreation scholarship fund.

The youth recreation scholarship fund was created by the Lemoore Lions Club over 15 years ago. Carolyn Arcino with the Lemoore Lions Club wanted to make sure that there was funding available so that children in the community who could not afford to pay for Lemoore Recreation Programs would still be able to participate. After the Lions Club saw the need for a scholarship program, they partnered with Lemoore Recreation and created Breakfast with Santa in order to raise revenue for the youth recreation scholarship fund.

Each qualifying family can get \$100 in scholarships per fiscal year. Qualifying families use to pay nothing if they registered for a program or event that was less than \$100. Two years ago, a new policy was put in place and the family would pay 25 percent of the program fee and the youth recreation fund would pay 75 percent. After looking at a customer's income, if a special circumstance was discovered such as 4 children in a program, both parents out of work, the 25 percent could not be paid or a bigger scholarship was needed, the Lemoore Lions Club or the Community Services Director could authorize an increase in funds.

## **UPDATE:**

This year's Evening Under the Stars was very well attended and brought in \$11,930 from ticket sales, sponsorships and the silent auction. After expenses of \$4,855.00, the event netted \$7,075.00. The event is truly one of a kind in Lemoore. It has been discussed as to whether it is profitable enough to continue the event considering how much staff time it takes to create Evening Under the Stars. On the front end, the recreation coordinator spent several hours organizing the event. The day of the event, three recreation staff and five maintenance staff set up and took down the event. The five maintenance staffing hours were all overtime hours. Staff is looking at ways to continuing the event but exploring options to reducing expenditures.
