Proposed Idea:

For the Recreation Department to sponsor a Farmer's Market in conjunction with Rockin' the Arbor which is sponsored by the Lemoore Chamber of Commerce.

Subject/Discussion:

For two years the Downtown Merchants hosted a Farmers Market in Lemoore on Friday evenings. Last year the Merchants decided not to bring it back. Our department has received numerous phone calls asking for a Farmer's Market. Staff contacted the Downtown Merchants this year and they will not be bringing the market back and suggested the Recreation Department handle it.

After brainstorming the idea, staff believes that combining it with "Rockin' the Arbor" on Friday evenings, June 3rd thru August 19th would be the ideal situation for the event and for our department. The Farmers Market was previously held on Fridays on "D" Street between Fox and Heinlen and competed with "Rockin' the Arbor". Our department feels that having one location would help both events. The Market Vendors would utilize the Arbor parking lot and there would be no street closures. The Recreation Department would keep the vendor fees for the market. The Chamber of Commerce has a set up and clean-up crew for "Rockin' the Arbor" and would not require any volunteers from our department on Friday evenings. The Chamber of Commerce is excited about the idea.

Financial Consideration(s):

On Friday evenings, one Recreation Coordinator would be at the event to help direct the Farmer's Market vendors to the right locations. This employee would come in late on Friday and still work only an 8 hour day.

Alternatives or Pros/Cons:

Pros:

Offers the community to again have a Farmer's Market

Utilizes and Chamber set up and clean-up crew that is already in place

Brings new people to both events. (Patrons of the market may stay and listen to the music, people listening to the music may buy produce)

Cons:

None at this time
