+ The dog has earned ,or if under three years old, is actively being trained and in the process of earning, an agility, carting, herding, protection, rally, hunting, working or other title from a registry or association recognized by the City of Lemoore Animal Control. **Attach original letter or certificate from the recognized registry or association.*

+ The dog is being, or has been appropriately trained and is actively used in a manner that meets the definition of guide, signal or service dog as set forth in Subdivisions (d), (e), and (f) of Section 365.5 of the California Penal Code, or the dog is enrolled in a guide, signal or service dog breeding program administered by a person licensed under Chapter 9.5 (commencing with section 7200) of Division 3 of the Business and Professions Code. **Attach original letter from trainer, or other proof of service dog status.*

+ The dog is appropriately trained or is in the process of being trained and is actively used by law enforcement agencies or the military for law enforcement, military or rescue activities. **Attach original letter or certificate from law enforcement agency with original signature.*

I hereby acknowledge that I am familiar with Lemoore Municipal Code sections dealing with Animal Control regarding the breeding of a dog and I declare that (initial each):

I will comply with any laws, ordinances, rules, and regulations applicable to owning, caring for, or breeding animals, and understand that nothing in the granting of this permit shall be interpreted as a waiver of any laws or regulations or the granting of any permission except the permission to breed a dog. It is my sole responsibility to promptly update any changes in the information provided on this application, including any change of addresses or telephone contact information, and that failure to provide such updated information to the City of Lemoore Animal Control within 30 days may result in the revocation of the Dog Breeding Permit. Any and all advertising of the litter shall include the Breeder's Permit number issued by City of Lemoore Animal Control. Initials ____

I understand that providing false or misleading information on this application may result in an immediate denial or revocation of the Dog Breeder's permit without refund of fee and order compelling the dog to be spayed/neutered within 60 days.
