

RESOLUTION NO. 8703

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEMOORE
CREATING AND ESTABLISHING A RECREATION COMMISSION

At a Regular Meeting of the City Council of the City of Lemoore duly called and held on January 20, 1987 at 7:30 p.m. on said day, it was moved by Councilmember Luis, seconded by Councilmember McKee and carried that the following Resolution be adopted:

WHEREAS, the City of Lemoore has recently entered into an agreement with the Lemoore Recreation Department whereby the Lemoore Recreation Department, a non-profit corporation, was merged into and absorbed by the City; and

WHEREAS, it is the desire of the City Council of the City of Lemoore to insure that continued recreational activities are available to the residents of the City of all ages; and

WHEREAS, it appears in the best interest of the City of establish a Recreation Commission, consisting of seven (7) members, to consider the recreational needs of the City, design and approve programs to meet the recreational needs of the residents of the City and thereupon to advise the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lemoore as follows:

1. There is hereby established a City of Lemoore Recreation Commission consisting of seven (7) members.
2. The members of the Commission shall be appointed by the Mayor with concurrence of at least two other members of the City Council. Each appointed member of the Recreation Commission shall serve for a period of four years. Three of the original commission appointees shall serve a term of two (2) years. The remaining four original appointees shall serve terms of four

(4) years. Following the expiration of the terms of the original commission appointees, all commissioners shall serve terms of four (4) years.

3. The Recreation Commission shall meet regularly, not less than monthly to consider the recreational needs of the residents of the City of Lemoore, of all ages. The Commission shall hold such public hearings as it deems necessary and shall give advice and recommendations to the City Council.


