What Is SGMA?

- Sustainable Groundwater Management Act SGMA
- Combination of three bills passed by the State Legislature and signed into law in September 2014
- Provides local agencies with framework to manage groundwater basins in a sustainable manner
- Groundwater sustainability agencies (GSAs) must submit a plan by January 2020 and reach sustainability by 2040





Sustainable Groundwater

- Sustainable groundwater management is defined as:
 - "management of groundwater supplies in manner that can be maintained in planning and implementation phases without causing undesirable results"

Sustainability Indicators



Sustainability Indicators



Chronic lowering of groundwater levels indicating a significant and unreasonable depletion of supply if continued over the planning and implementation horizon.



Significant and unreasonable reduction of groundwater storage



Significant and unreasonable seawater intrusion



Significant and unreasonable degraded water quality, including the migration of contaminant plumes that impair water supplies



Significant and unreasonable land subsidence that substantially interferes with surface land uses



Depletions of interconnected surface water that have significant and unreasonable adverse impacts on beneficial uses of the surface water

Iterative Process



2018 Annual Fire Report

The Lemoore Volunteer Fire Department is comprised of 35 volunteer members, 8 of which are certified Emergency Medical Technicians, 23 hold their Firefighter I certificate, and 8 hold their Firefighter I/II certificate. LVFD strives to provide the community with the best Fire Protection service possible.

In 2018, the Lemoore Volunteer Fire Department responded to a total of 1,871 incidents. The charts below show a breakdown of the incident calls for 2018.

In addition to responding to incidents, LVFD held 52 mandatory drill meetings and performed an additional 26 public services activities and trainings throughout the year. The public service activities include participating at National Night Out, the Pizza Festival, the Christmas Parade, the Veterans Parade, and numerous tours of the fire station for local schools and organizations. Services also included standing by at many of the Lemoore High School football games, performing firework stand inspections, and additional work details at the fire station.

LVFD was able to provide this level of service with an annual budget of \$501,030. Within this year's CIP budget the Fire Department was able to purchase a new Medical/Rescue Fire Truck #13 that replaced the 1997 Ford Fire Truck.

Lemoore Volunteer Fire Department takes pride in the ability to serve the great community that is Lemoore, and appreciates the opportunity to do so.
