STUDY SESSION

SS-1 Worker's Compensation Alternative Dispute Agreements between the City of Lemoore and all Bargaining Units (Venegas)

HR/Risk Management Manager Venegas introduced John Ferrone with Adams, Ferrone & Ferrone who presented on the Alternative Dispute Resolution for Workers Compensation which included:

- The Current Statutory System
 - The worker's compensation system is averaging almost one year from the time a claim is filed before the claim is resolved.
- Worker's Compensation Dynamics
 - Track One: Accepted Cases
 - Admitted Cases
 - Injured officer being paid 4850 pay and seeking medical treatment
 - Medical treatment subject to UR (Utilization Review)
 - IMR Independent Medical Review
 - All treatment disputes must go through IMR. The parties cannot use a QME or AME.
 - Tack Two : Denied Cases
 - Delay/Denied Claims
 - 14 days to notify if claim is on delay
 - Time Lines
 - Exam schedule is 2-4 months out & 2-4 months for report receipt (up to 8 months)
 - Denied Claims
 - Take up to 9-12 months to resolve before triggering benefits
- Independent Medical Examiners
 - Physicians chosen based on availability to be impartial, straight forward, and fair
 - Physician list negotiated by City Management and labor associations' representatives

- Good report writing and understanding of issues
- Agreed to 30 day exams and 30 days after exam the medical reports would be served
- Physician list encompasses all medical specialties from acupuncture to psychiatry
- o Physicians on the list rotates from top to bottom
- Measurements of Success
 - County of Kern Estimates introduction of program to save at a minimum of \$580,000 for the Sheriff's Department and estimates a savings of \$666,000 for the Fire Department
 - Orange County Fire Authority Reported savings in overtime and backfill costs of \$592,000. Total savings after ADR implemented \$1.5 million
- What an ADR System Can Do
 - Provides employees with a fast track system to resolve worker's compensation disputes
 - Reduces overtime wages
 - Reduces sick leave for an injured worker
 - Reduces litigation expenses
 - o Improves employee morale
 - o Resolves claims in under 90 days vs. 180 days to a year
 - Efficiently gets the injured worker the help they need
- Next Steps
 - Submit documents to State of California for final approval
 Minimum of 30 days required for processing
 - After final approval received. ADR program takes effect
 - Anticipate January 1, 2020 start date

Proposed Motion:

Approve the Memorandum of Understanding (MOU) between the Counties of Kings and Tulare and Cities of Lemoore, Dinuba, Exeter, Farmersville, Hanford, Lindsay, Tulare, Visalia and Woodlake for the Tulare-Kings County Regional Hazardous Material (Haz-Mat) Team and authorize the City Manager or his designee to execute the contract and budget amendment.

Subject/Discussion:

The MOU is a cooperative agreement between the agencies to provide technical services at the scene of a hazardous materials incident within the operational areas of the participating agencies. The agencies signing this agreement have determined that a multi-agency regional team provides an efficient and cost-effective method to provide such services.

The City of Visalia, through the City of Visalia Fire Department (VFD), will serve as the lead agency for the Haz-Mat team. As the lead agency, VFD will be primarily responsible for housing the Haz-Mat team equipment, scheduling training on a regional basis, accounting for funding, facilitating cost recovery efforts and assembling personnel for

each Haz-Mat response. This MOU is a supplement to existing mutual aid agreements and provides the City of Lemoore with expert Haz-Mat response in the event of a critical incident.

In this MOU, all parties agreed that each agency shall be responsible for its respective share of costs to equip and maintain the Haz-Mat team on an annual basis. Per Exhibit A of the MOU, The City of Lemoore is responsible for \$3,327.62; this fee covers the period of July 1, 2019 through June 30, 2020. The term of the agreement is from July 1, 2019 to June 30, 2024 (a period of five years), with the option for 5-year term renewals.

The City of Lemoore has an option to deny participation in the regional unit. However, in the event of a critical Haz-Mat incident, response would not be guaranteed. In the event that the team was able to respond, the City of Lemoore would be financially responsible for the full cost of the response. City staff evaluated the benefit of joining the regional team and decided that the cost for annual participation was minimal and would result in guaranteed response of a Type I team.

Financial Consideration(s):

The City of Lemoore shared responsibility is \$3,327.62 annually for the term of the Agreement. The amount will be paid out of the Fire budget 4222-4310. We are requesting a budget amendment from Reserves to the Fire budget to cover the expense.

MEMORANDUM OF UNDERSTANDING BETWEEN

INTRODUCTION

This Memorandum of Understanding ("MOU" or "Agreement") is entered into between Kings County, Tulare County, City of Dinuba, City of Exeter, City of Farmersville, City of Hanford, City of Lemoore, City of Lindsay, City of Tulare, City of Visalia, and City of Woodlake (jointly referred to as "Parties"). The MOU is for the purpose of entering into a cooperative agreement between the agencies listed above to provide technical services at the scene of a hazardous materials incident within the operational areas of the participating agencies within Tulare County and Kings County. The agencies signing this Agreement have determined that a multi-agency regional team provides an efficient and cost-effective method to provide such services under the terms of this MOU.

By commitment of resources as described in this MOU, the agencies will develop the Tulare-Kings County Regional Hazardous Materials Team, ("Haz-Mat Team") which will serve to provide for response to incidents involving hazardous materials to the best of the participating agencies' collective abilities and capabilities. The Haz-Mat Team will be a resource that is on-call when needed for the participating agencies, if resources are available, and will not circumvent the requesting agency's statutory authority.

The City of Visalia, through the City of Visalia Fire Department ("VFD") will serve as the lead agency for the Haz-Mat Team. As the lead agency the VFD will be primarily responsible for housing the Haz-Mat Team equipment, schedule training on a regional basis, accounting for the Haz-Mat Team funding, cost recovery efforts as specified in this Agreement, assembling and scheduling the available personnel for each Haz-Mat Team response.

1. PURPOSE

This Agreement is to create and maintain a regional hazardous materials response team, as a supplement to existing mutual aid agreements, that will be composed of staff from participating agencies, as available, to provide first responder operational and technical services at the scene of hazardous materials incidents within the jurisdictional areas of the Parties.

To the extent that the Parties previously operated under cost sharing agreements with the City of Visalia for hazardous materials response, this agreement is intended to replace those prior cost sharing agreements.

2. NO SEPARATE ENTITY

The Parties agree that the purpose of this Agreement may be accomplished without creating a separate entity from the Parties. The Parties to this Agreement are hereby expressly stating that this Agreement does not and is not intended to create a separate joint powers agency or any other type of entity separate and apart from the Parties to this Agreement.

Parties agree that the employees of each respective participating local agency remain the employees of that participating local agency and this Agreement does not make the Parties responsible in any way for the employees of another participating local agency.

3. DUTIES OF PARTIES

The Parties to this Agreement hereby agree that each will undertake the following duties and responsibilities:

- A. Each Party shall take steps, to the extent its resources permit, to train and certify at least one person qualified to provide Hazardous Materials Technician services or four persons qualified to provide First Responder Operational decontamination services.
- B. Each Party, may, at its discretion, acquire and maintain material and supplies necessary to provide equipment and support Haz-Mat Team operations.
- C. Each Party shall contribute funds, or materials, as specified in Exhibit A to this Agreement in order to financially support the costs associated with equipping and maintaining the Haz-Mat Team. Each Party shall pay its required share on or before October 1, of each year, either in a lump sum or in a payment schedule arranged with the lead agency. Failure to pay shall be considered a breach of this Agreement.
- D. This Agreement is intended to state an agreement by participating agencies to cooperate in responding to hazardous materials incidents but each Party acknowledges that this Agreement does not negate or alter its obligation to respond to any such incident occurring within its jurisdictional boundaries.
- E. At the sole discretion of each participating agency, a Party under this Agreement may request the Haz-Mat Team respond to the scene of a hazardous material incident within the participating agency's jurisdiction.
- F. Under the direction of the jurisdiction having legal scene management authority and responsibility, the Haz-Mat Team shall have control of all matters pertaining to the containment and decontamination of a hazardous materials incident until relieved of responsibility by the requesting Party or by the legal scene manager.
- G. VFD as the designated lead agency, shall, at its discretion and based on operational requirements, request Parties send trained personnel as part of a Haz-Mat Team response. Parties shall not be required to respond to a request for resources if it does not have sufficient personnel or equipment to respond at the time the request is made.

- H. Except as agreed to under this Agreement, each Party agrees to be solely responsible for the costs of their personnel, resources administration, training, and emergency response within its respective jurisdiction.
- I. Parties agree that if the Haz-Mat Team responds to a jurisdiction that is not a Party to this Agreement, then the VFD, as the agent for the Haz-Mat Team, shall bill that jurisdiction the applicable cost recovery for the Haz-Mat Team response. Cost recovery to local agencies may be offset by any amount collected from the party responsible for causing the hazardous material incident, if any, under available statutory law for cost recovery. Cost recovery among Parties with personnel on the responding Haz-Mat Team will be based on the applicable cost rate for the respective personnel involved.

4. INDEMNIFICATION

The Parties to this Agreement recognize the statutory immunities stated in Government Code Sections 850 et seq., Health and Safety Code Section 25400 and 42 U.S.C. Section 9607(d)(2) from liability, claims, actions, costs damages or losses, including death or injury to any person and/or damage to property to each other and third parties for personal injury, including death, and property damage arising out of acts or omissions, including the active or passive negligence, which may occur while the respective departments of the Parties take action in response to hazardous material incidents under this Agreement. These immunities, or any other governmental immunity, that do not extend to liability for personal injury, including death, and property damage arising out of any act or omission of any party to this Agreement which act or omission is performed in a grossly negligent manner or to liability for any injury or damage which is a result of bad faith, gross negligence or intentional misconduct, as those terms are defined or used under the statutory immunities cited above are referred to herein as "gross negligence or intentional misconduct."

When the statutory liability immunities cited above apply there shall be no obligation by any Party to this Agreement to indemnify any other Party pursuant to this section of the Agreement.

Where any liability, claims, actions costs, damages or losses of any kind, including death or injury to any person and/or damage to property, (referred to as "claims" herein) are asserted by any third party or Party to this Agreement to have arisen out of any action or omission of a Party to this agreement which act or omission is or alleged to have been gross negligence or intentional misconduct by such Party, the Party or Parties whose actions which are alleged to have been gross negligence or intentional misconduct shall hold harmless, defend and indemnify the other Parties to this Agreement from and against any liability, claims actions, costs, damages or losses of any kind, including death or injury to any person and/or damage to property alleged to have arisen out of gross negligence or intentional misconduct. This indemnification shall include claims or any such liability assignable to the indemnified Parties on the theory or basis of respondeat superior or agency. This indemnification obligation shall continue beyond the term of this Agreement as to any acts or omissions occurring under this Agreement or any extension of this Agreement. Parties agree that if proportional liability is determined for incidents described in this paragraph, then each shall bear its proportionate cost of any claims respectively attributable based on the applicable facts and circumstances. Parties shall indemnify/hold harmless other Parties that may have been named or involved in the action for any costs or damages incurred in this paragraph its respective proportionate liability.

To the extent that the paragraphs above do not apply to any claims that any third party or entity asserts to have risen out of the activities or omissions, including active or passive negligence, of a Party whose employees or equipment were included in a response by the Haz-Mat Team under this Agreement, then the Party that has jurisdiction over the location of the incident and that requests the Haz-Mat Team shall hold harmless, assume the defense of, and indemnify the other Parties to this Agreement from and against such claims. This indemnification shall include claims or any such liability assignable to the indemnification parties on the theory or basis of respondeat superior or agency. This indemnification obligation shall continue beyond the term of the Agreement as to any acts or omissions occurring under this Agreement or any extension of this Agreement.

In any instance where claims name multiple Parties, then the Party with the majority of the employees in the Haz-Mat Team that responded to the incident shall assume the lead in defense unless otherwise agreed to by the Parties.

Each Party shall notify the other participating agencies in writing of any claims, administrative actions, or legal actions with respect to any of the matters described in this indemnification provision within five (5) business days of becoming aware of a claim or action. The Parties shall cooperate in the defense of such actions brought by others with respect to the matters covered in this Agreement. Nothing set forth in this Agreement shall establish a standard of care for, or create any legal rights in, any person not a party to this Agreement.

The provisions of this indemnification clause are intended to be interpreted as broadly as permitted by applicable law. This provision shall survive the termination, expiration, or cancellation of this Agreement.

5. INSURANCE

It is understood and agreed that each Party does and shall maintain insurance policies or self-insurance programs to fund their respective potential liabilities, including potential liability arising out of their personnel responding to hazardous materials incidents and the ownership, maintenance, operation, and use of equipment or procedures used in responding to hazardous materials incidents. Each Party agrees that their respective insurance policies or self-insurance policies shall be modified as necessary to include reasonably foreseeable liability arising out of this Agreement.

Each Party is responsible for providing all required worker's compensation benefits and administering worker's compensation for its employees.

Each Party hereby grants to the other Parties and the other Parties' respective officers, officials, employees, and volunteers a waiver of any right to subrogation in regards to the activities referenced in this Agreement which any insurer of the waiving Party may acquire against the other Parties and/or other Parties' respective officers, officials, employees, and volunteers by virtue of the payment of any loss under insurance maintained by the waiving Party. Each Party shall obtain the endorsement(s) necessary to effect this waiver of subrogation, but this provision applies regardless of whether or not the waiving Party obtain and provides the required endorsement(s) to the other Parties.

6. COST RECOVERY AMONG PARTIES

Cost recovery fees will not be charged to Parties. The only type of cost recovery that will be undertaken when the Haz-Mat Team responds to an incident in the jurisdiction of a Party will be to seek reimbursement from those persons and entities responsible for the incident under applicable state or local laws permitting cost recovery. Participating Parties agree to cooperate with one another in cost recovery.

The City of Visalia shall coordinate and monitor cost recovery efforts. Each Party shall provide Visalia with the applicable cost recovery rates for its personnel that serve on the Haz-Mat Team. For purposes of cost recovery, the Parties shall designate City of Visalia, acting through the VFD, as their agent to seek cost recovery of personnel that responded as part of the Haz-Mat Team.

Within thirty days of a hazardous materials incident each Party shall provide VFD with a record of all costs of resources, personnel, and equipment, deployed to the hazardous materials incident.

City of Visalia, as the designated agent under this Agreement, shall collect through cost recovery efforts all amounts expended by the Parties under this Agreement. Each Party shall cooperate with VFD in collection efforts for incidents that occur within their respective jurisdictional boundaries. All cost recovery revenue shall be reimbursed to the Party that incurred the expense. All Parties agree to account for Haz-Mat Team expenses incurred by their respective agency in an account separate from other revenues and expenditures.

Parties agree that VFD, as the lead agency (and primary location for Haz-Mat Team equipment) shall establish an administrative per incident fee of \$300.00 that will be applied to reimburse VFD the administrative costs of assembling the specific personnel that will be responding to each specific hazardous material incident. This per incident fee will only apply when the VFD coordinates a response by the Haz-Mat to a request for assistance.

7. TERM

The initial term of this Agreement shall be for five years effective July 1, 2019 and ending June 30, 2024. The Parties may mutually agree to extend this Agreement for additional five-year terms.

8. TERMINATION

A Party to this Agreement may voluntarily terminate participation upon one hundred eighty (180) calendar days written notice to all other Parties.

Parties that are in breach of the terms of this Agreement shall be notified in writing and have ninety (90) calendar days from the date of such notice to comply with the terms of the Agreement or its participation will be terminated.

Upon the effective termination date, any required contributions under this Agreement that were paid in advance shall be prorated and potentially refunded based on the number of months during the applicable fiscal year that a Party is involved in this Agreement.

Notwithstanding a Party's withdrawal or termination, that Party may continue to receive cost recovery reimbursements as provided under this Agreement for costs incurred while the Party operated under this Agreement and provided personnel or equipment to a hazardous material incident prior to termination.

9. ADDITIONAL PARTIES

Parties agree that additional agencies may join this Agreement at any time. VFD shall notify the existing Parties in writing of any agencies that seek to be added to this Agreement. The notice by VFD shall include any draft cost adjustments to the contributory amounts required under this Agreement that will go into effect with the addition of the new Party. VFD shall reissue the section concerning notice and the revised schedule of costs based on the addition of a new Party and a copy of the signature page of the Agreement signed by the new Party. The additional agency shall be added as a Party to this Agreement unless an existing Party objects within thirty (30) calendar days of being notified of the addition. In case of an objection, all then-current Parties shall meet and decide by a majority vote of currently participating Parties whether to include the additional agency.

10. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding of the Parties. With the exception of Section 9, allowing additional agencies to participate, and Exhibit A, allowing population data to be changed as census data is updated and annual costs to increase by a set amount per year; no changes, modifications, or alternations, shall be effective unless in writing and signed by all Parties.

11. COUNTERPARTS

This Agreement may be executed in counterparts, each of which shall be deemed an original, all of which together shall constitute one and the same instrument.

Exhibit A Cost Responsibility

The Parties agree that each agency shall be responsible for its respective share of costs to equip and maintain on an annual basis the Haz-Mat Team.

The Parties, by this Agreement have agreed that on an annual basis the Haz-Mat Team should be funded \$72,562.22, which amount shall increase annually at a rate of two percent (2%) unless a different amount is agreed upon in writing by all the Parties to this Agreement.

The Parties agree that their share of the annual cost share shall be based on the respective populations of each jurisdiction compared to the total overall population of all participating jurisdictions. As census data is updated then the Parties agree to update this section of this Agreement based on the most recent census data.

In consideration of the City of Hanford transferring ownership of the 2007 Pierce Hazardous Materials Unit to the City of Visalia for use by the Haz-Mat Team, the Parties agree that Hanford shall be credited as contributing \$100,240 or ten (10) years of payments, whichever occurs first. The City of Hanford annual contribution shall be first subtracted from this amount before any additional amounts are owed. VFD shall adopt an applicable cost recovery rate for this vehicle that shall be applied to cost recovery charges for the VFD as it will have the responsibility to maintain and operate the unit on behalf of the Haz-Mat Team. In case the City of Hanford terminates this Agreement prior to this credit ending, then the City of Visalia shall either return the 2007 Pierce Hazardous Materials Unit or pay the City of Hanford the outstanding balance of the credit listed in this paragraph to retain the vehicle.

Proposed Motion:

Approve, by motion, Resolution 2019-50 authorizing the transfer of funds to properly allocate revenues and related expenditures.

Subject/Discussion:

The Finance Department recently completed a three year analysis of financial activity within Fund 28 in order to ensure that restricted project revenues have been correctly matched with related expenditures within the Fund. As a result of our analysis, staff determined that in certain situations the related revenue and expenditures were recorded in different funds. Additionally, staff determined that funding encumbered for certain projects by Council were not transferred to the fund where the expenditures were recorded. The following includes transfers that staff determined will be necessary to properly allocate the revenues and related expenditures to the appropriate funds. Please note that the following transfers will not result in any change in the overall fund balance of the City as a whole:

 \$120,475.00 transfer from Fund 029 to Fund 028 – Expenditures for the Lions Park Playground construction, which was completed in FY2016, were recorded in Fund 028; however, a portion of those costs were meant to be covered by available funding within Fund 029. This amount was not transferred to Fund 028 at the completion of the project.

- 2) \$119,000.00 transfer from Fund 034 to Fund 028. Expenditures for the Cinnamon Street Overlay project, which was completed in FY2016, was recorded in Fund 028; however, a portion of those costs were meant to be covered by available funding within Fund 034. This amount was not transferred to Fund 028 at the completion of the project.
- 3) \$94,009.43 transfer from Fund 028 to Fund 065. Cash was received in FY2018 for the In Roadway Lighting project and deposited into Fund 028 although the related expenditures for this portion of the project were incurred in Fund 065.
- 4) \$178,223.00 transfer from Fund 028 to Fund 001 The City collects funding from the Supplemental Law Enforcement Services Fund (SLESF) annually to supplement expenses for front-line police officers. Funding for FY2016 and FY2018 was recorded in Fund 028 and expenses for police officers were recorded in Fund 001. This amount was not transferred to supplement the costs of the police officers accounted for in Fund 001.
- 5) \$954,900.15 transfer from Fund 028 to Fund 401 The Finance Department would like to create Fund 401, called Public Safety Dispatch Center, to track all revenues and expenditures related to the Public Safety Dispatch Center construction. This initial transfer would cover the \$939,000 received in FY2016 from the State of California for this project plus interest earned on this amount.
- 6) \$40,128.37 transfer from Fund 401 to Fund 001 Beginning in FY2016, costs for the Public Safety Dispatch Center were recorded in Fund 001. After the creation of Fund 401, this transfer will reimburse Fund 001 for all costs prior to FY2019. (FY2019 costs will be moved to Fund 401 through a journal entry).
- 7) \$532,377.63 transfer from Fund 033 to Fund 028 A portion of costs for certain projects expensed in Fund 028, including the CMC Underground Canal, were not recovered for with available funding from other funds. Finance has determined that available fund balance within Fund 033 is available to cover the costs for these projects.
- 8) \$3,523.43 transfer from Fund 029 to Fund 028 Costs for the 19 ½ Sidewalk project were expended from Fund 028; however, a portion of those costs were meant to be covered by available funding within Fund 029. This amount was not transferred to Fund 028 at the completion of the project.
- 9) \$4,226.30 transfer from Fund 029 to Fund 001 Expenditures for the 19th and Cedar Traffic Signal project were recorded in Fund 001; however, a portion of those costs were meant to be covered by available funding within Fund 029. This amount was not transferred to Fund 001.

Financial Consideration(s):

The transfer of funds will not result in any change in the overall fund balance of the City as a whole.

Alternatives or Pros/Cons:

None noted.

RESOLUTION 2019-51

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEMOORE SUPPORTING THE REDUCING CRIME AND KEEPING CALIFORNIA SAFE ACT OF 2020.

WHEREAS, protecting every person in our state, including our most vulnerable children, from violent crime is of the utmost importance. Murderers, rapists, child molesters and other violent criminals should not be released early from prison; and

WHEREAS, since 2014, California has had a larger increase in violent crime than the rest of the United States. Since 2013, violent crime in Los Angeles has increased 69.5%. Violent crime in Sacramento rose faster during the first six months of 2015 than in any of the 25 largest U.S. cities tracked by the FBI; and

WHEREAS, The FBI Preliminary Semiannual Uniform Crime Report for 2017, which tracks crimes committed during the first six months of the past year in U. S. cities with populations over 100,000, indicates that last year violent crime increased again in most of California's largest cities.

WHEREAS, recent changes to parole laws allowed the early release of dangerous criminals by the law's failure to define certain crimes as "violent." These changes allowed individuals convicted of sex trafficking of children, rape of an unconscious person, felony assault with a deadly weapon, battery on a police officer or firefighter, and felony domestic violence to be considered "nonviolent offenders."; and

WHEREAS, as a result, these so-called "non-violent" offenders are eligible for early release from prison after serving only a fraction of the sentence ordered by a judge; and

WHEREAS, violent offenders are also being allowed to remain free in our communities even when they commit new crimes and violate the terms of their post release community supervision, like the gang member charged with the murder of Whittier Police Officer, Keith Boyer; and

WHEREAS, this measure reforms the law so felons who violate the terms of their release can be brought back to court and held accountable for such violations; and

WHEREAS, nothing in this act is intended to create additional "strike" offenses which would increase the state prison population, nor is it intended to affect the ability of the California Department of Corrections and Rehabilitation to award educational and merit credits; and

WHEREAS, recent changes to California law allow individuals who steal repeatedly to face few consequences, regardless of their criminal record or how many times they steal; and

WHEREAS, as a result, between 2014 and 2016, California had the 2nd highest increase in theft and property crimes in the United States, while most states have seen a steady decline.

According to the California Department of Justice, the value of property stolen in 2015 was \$2.5 billion with an increase of 13 percent since 2014, the largest single-year increase in at least ten years; and

WHEREAS, grocery store operators around the state have seen unprecedented increases in the amount of losses associated with shoplifting in their stores, with some reporting up to 150% increases in these losses from 2012 to present, with the largest jumps occurring since 2014; and

WHEREAS, shoplifting incidents have started to escalate in such a manner that have endangered innocent customers and employees; and

WHEREAS, individuals who repeatedly steal often do so to support their drug habit. Recent changes to California law have reduced judges' ability to order individuals convicted of repeated theft crimes into effective drug treatment programs; and

WHEREAS, California needs stronger laws for those who are repeatedly convicted of theft related crimes, which will encourage those who repeatedly steal to support their drug problem to enter into existing drug treatment programs. This measure enacts such reforms; and

WHEREAS, collecting DNA from criminals is essential to solving violent crimes. Over 450 violent crimes including murder, rape and robbery have gone unsolved because DNA is being collected from fewer criminals; and

WHEREAS, DNA collected in 2015 from a convicted child molester solved the rapemurders of two six-year-old boys that occurred three decades ago in Los Angeles County. DNA collected in 2016 from an individual caught driving a stolen car solved the 2012 San Francisco Bay Area rape/murder of an 83-year-old woman; and

WHEREAS, recent changes to California law unintentionally eliminated DNA collection for theft and drug crimes. This measure restores DNA collection from persons convicted for such offenses; and

WHEREAS, permitting collection of more DNA samples will help identify suspects, clear the innocent and free the wrongly convicted, and

WHEREAS, this measure does not affect existing legal safeguards that protect the privacy of individuals by allowing for the removal of their DNA profile if they are not charged with a crime, are acquitted or are found innocent.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Lemoore herby supports the Reducing Crime and Keeping California Safe Act of 2020.

Approve Resolution 2019-52, authorizing the City Manager, or designee, to execute the reorganization of the Lemoore Police Department.

Subject/Discussion:

The Lemoore Police Department is seeking to reorganize in light of the appointment of Chief Kendall, the reduction of commanders, and several other factors, which have resulted in a shift of responsibility for Lemoore Police Department Staff. It is the intent of the Police Chief to restructure in order to provide for efficient allocation of assignments, provide mentorship to staff and to assist in oversight of new regulations and divisions.

The proposed new structure will amend the current position allocation. The current position allocation accounts for the following:

Chief	1
Commander	2
Sergeant	5
Corporal	6
Police Officer	19

The proposed position allocation is as follows:

Chief	1
Captain	1
Lieutenant	2
Sergeant	5
Corporal	5
Police Officer	19

In October 2017, City Council approved job descriptions for all City positions, as well as job descriptions for several positions which the City felt may be needed in the future. One such position was that of a Police Lieutenant. The Lemoore Police Department is now seeking City Council approval to authorize two (2) Lieutenant positions. The lieutenants will be responsible for oversight of patrol operations, support divisions, as well as oversight of compliance issues related to cannabis operations within the City.

Chief Kendall has been working with Human Resources and the City Manager to develop a strategy that will assist in accomplishing the tasks of the Lemoore Police Department, while limiting the burden to the annual operating budget of the Police Department. In addition to adding two (2) lieutenant positions to the position allocation, Chief Kendall is asking for a reduction of one (1) corporal position. The reduction in a corporal position will not result in layoffs, the reduction will occur through promotional opportunities.

Additionally, Chief Kendall is requesting a retitling of the Police Commander position to that of Police Captain. The retitling is necessary in order to align the department with more appropriate titles for their rank structure. Although the job description for the Police Captain will remain unchanged from that of a Police Commander, a salary adjustment is required due to the addition of a Police Lieutenant within the ranks.

In 2017, the City of Lemoore conducted a classification and compensation study. Although the compensation study was not implemented due to lack of funding, the City strives to ensure that salary compaction issues do not arise with the addition of new positions. As such, Human Resources is recommending that Police Lieutenant be added to the Salary Matrix as a Range 117 and that the Police Captain be assigned a range of 127.

Overall, there will not be any additional fulltime equivalent (FTE) personnel to the Lemoore Police Department. The recommended salary structures, and requested positions may result in an increase to the Lemoore Police Department salaries of no more than \$8,000. With salary savings from vacant positions, and movement of personnel, it is likely that the changes will not result in any increase for FY20.

Financial Consideration(s):

The addition of two (2) Lieutenants, reduction of one (1) Corporal, retitling of one (1) Commander to Captain, and adoption of salary ranges as identified above, may result in an increase to the Lemoore Police Department salaries and benefits of not more than \$8,000 for FY20.

- 4. The City Manager and staff are hereby authorized to implement this Resolution and fill the positions if vacant.
- 5. This Resolution shall be effective immediately upon its adoption.

Proposed Motion:

Award bid to Romanazzi General in the amount of \$805,000 and authorize the City Manager, or designee, to sign the contract and budget amendment following review and approval by the City Attorney.

Subject/Discussion:

On June 19, 2018, City Council authorized staff to move forward with the dispatch center project in order to provide dispatching services for the Police Department and the Lemoore Volunteer Fire Department. Completion of the project will provide a better level of service to both the Police and Fire Departments as well as to the citizens of Lemoore.

The City solicited bids from qualified contractors for the site improvements for the Dispatch project. The estimated cost for this portion of the project was \$600,000. Bids were opened on October 17, 2019 and were as follows:

Staff is recommending the project be awarded to Romanazzi Gen., in the amount of \$805,000; and allocate \$80,500 to the CIP for contingency. The contingency is utilized to fund any potential change orders. If no change orders are issued during the course of the project, the city retains the funds associated with the contingency. The project will commence upon contract approval.

Financial Consideration(s):

The current budget for CIP 5712 is \$2,640,000 for fiscal year 2019-2020. Of that, \$1,949,240 has been expensed/ encumbered, leaving an available balance of \$690,760. Staff is asking for a budget amendment of \$200,000 from the general fund reserves to cover the costs for the site improvements and soil testing. The dispatch project is funded through multiple sources; general fund, state grants, law and fire development impact fees.

Alternatives or Pros/Cons:

Pros:

- Provides for the space necessary for development of the City of Lemoore Dispatch.
- Provides for the space necessary to accommodate staff.
- Will provide for better service to public safety personnel and the public.

Cons:

• An additional \$200,000 will be needed from the General Fund to cover expenses.

Staff recommends that the City Council award the bid for the Dispatch Project per bid specification to Romanazzi General, in the amount of \$805,000 and authorize the City Manager, or designee, to sign the contract and budget amendment. AGREEMENT

THIS AGREEMENT, entered into by and between

C. TIME OF PERFORMANCE

The Contractor shall begin work within ten (10) consecutive calendar days after execution of the contract by the City and receipt of the *Notice to Proceed* from the City. Time of completion for the work shall be ______ working days from (a) the date of commencement of the work as established in the City's Notice to Proceed, or (b) if no other date is established in a Notice to Proceed from City, the date of Contractor's actual commencement of the Work (including mobilization).

Liquidated damages will accrue and may be assessed as provided in the Contract Documents. Should said work not be completed within the time limit as may be extended as herein provided, damages will be sustained by the City. It is understood and agreed that it is and will be impracticable or extremely difficult to determine the actual amount of damages which the City will sustain in the event of and by reason of such delay, and it is therefore agreed that the Contractor will pay the City the sum of One Thousand (\$1,000) per calendar day for each and every day's delay beyond the time specified as and for liquidated damages, during or as a result of each calendar day by which completion of the project is delayed beyond the completion date; in case the Contractor fails to make such payment, the City may deduct the amount thereof from any money due or that may become due the Contractor under the Contract. Should such money not be sufficient, the City shall have the right to recover the balance from the Contractor or its sureties.

The work shall be completed within the times set forth in the Special Provisions. Time is of the essence, and forfeiture due to delay will be assessed the Contractor as provided for in the Supplementary Conditions.

D. PAYMENTS

Payments will be made by the City to the Contractor for said work performed at the times and in the manner provided in the Specifications and at the prices stated in the Contractor's bid.

E. ASSIGNMENT

Contractor offers and agrees that it will assign to the purchasing body all rights, title, and interest in and to all causes of action it may have under section 4 of the Clayton Act (15 U.S.C., Sec. 15) or under the Cartwright Act (Chapter 2 (commencing with Section 16700) of Part 2 Division 7 of the Business and Professions Code), arising from purchases of goods, materials, or services by the bidder for sale to the purchasing body pursuant to the Contract.

F. CHANGES

Changes in this agreement or in the work to be done under this agreement shall be made as provided in the General Conditions.

G. TERMINATION

The City and Contractor may terminate this agreement as provided in the General Conditions.

The terms of the agreement shall not be waived, altered, modified, supplemented or amended in any manner whatsoever except by written agreement signed by the parties and approved or ratified by the Governing Board.

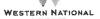

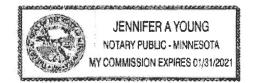

On November 6, 2019, Council approved a contract with IG Services for a Refuse Rate Study in the amount of \$20,740. LETTER AGREEMENT FOR CONSULTATIVE SERVICES

This Letter Agreement sets forth the agreement and understanding between the City of Lemoore and Interstate Gas Services, Inc. (DBA IGService and IGS), for IGS to provide analysis and recommendations for Lemoore's refuse services and rate structure.

SCOPE AND SCHEDULE:

The detailed scope and budget are shown in Exhibit A. Overall, the purpose of the rate study is to first evaluate existing services, revenue, expenses, and rate structure. Next is to determine future needs for expanded services and anticipated expenses, then set rates for services such that fees collected are consistent with the costs of each service (land fill, recycle, green waste, organics).

The study will also focus on costs associated with operation of city-owned equipment providing services to provide detail of operating costs to provide services, including life-cycle costs of existing and future anticipated equipment needed. IGS will work collaboratively with city staff to enable staff to have input and fully understand cost assignment and the rate-setting process.

Work will commence within four weeks of approval by Lemoore, and be completed with four months.

FEES AND BILLING:

As principal consultant, Dan Bergmann of IGS shall perform this work. Billing statements shall show detail of work, including hours and tasks by specific day.

TERM:

This Agreement commences as of full execution and shall terminate six months following full execution.

IGS: Lemoore:

INDEPENDENT CONTRACTOR:

In performing under this Agreement, IGS shall act at all times as an independent contractor. IGS shall not make any commitment or incur any charge or expense in the name of Lemoore, unless explicitly authorized to do so by the Lemoore city manager or city council as appropriate.

IGS expressly agrees, acknowledges, and stipulates that neither this Agreement nor the performance of its obligations or duties thereunder shall ever result in IGS, or anyone employed by IGS, being:

- A. An employee, agent, servant or representative of Lemoore; or
- B. Entitled to any benefits from Lemoore, including, without limitation, pension, profit sharing, accident insurance, or health, medical, life, or disability insurance benefits or coverage, to which employees of Lemoore are entitled.

The sole and only compensation and/or benefit of any nature to which IGS shall be entitled are the payments provided for herein. Lemoore shall have no direction or control of IGS or its employees and agents except in the results to be obtained subject to Lemoore's right to review/inspect the services. The actual performance and supervision of all services shall be by IGS, but the services shall meet the approval of Lemoore.

SOCIAL SECURITY AND WAGE TAX LIABILITY/WORKER'S COMPENSATION INSURANCE:

IGS agrees to pay timely and to accept exclusive liability for the payroll taxes, contributions for unemployment compensation insurance, old age benefits, social security, and any other payments now or hereafter imposed by the Government of the United States or by any state or political subdivision thereof, which are measured by the wages, salaries or other remuneration paid to IGS employees. IGS agrees to indemnify Lemoore and save it free and harmless from and against any and all taxes, contributions, and/or payments imposed by law upon IGS. IGS will at all times carry and provide worker's compensation insurance coverage for its employees.

ASSIGNMENTS AND SUBCONTRACTS:

This Agreement and all duties and obligations described hereunder are personal in nature. Accordingly, IGS shall not assign this Agreement or any portion thereof or subcontract to another party, unless explicitly authorized to do so by the Lemoore city manager.
