Minutes of the Special Meeting of the
LEMOORE PARKS AND RECREATION COMMISSION
October 8, 2019

1. Call to Order

At 5:30 p.m. the meeting was called to order.

2. Roll Call: Chairperson: Steve Rossi
Vice Chairperson Ernest Smith

Absent: Robert Escalera (*arrived at 5:37 p.m.*)

City Staff present: Parks and Recreation Director Glick; City Clerk Avalos; Recreation Coordinator Taylor; Recreation Coordinator Cuevas.

4. PUBLIC COMMENT:

There was no comment.

5. APPROVAL – Minutes – Regular Meeting – June 12, 2019

Motion by Commissioner Jordan, seconded by Commissioner Smith, to approve the Minutes from the Special Meeting of June 12, 2019.

6. INFORMATION ONLY – Summer Day Camp Program:

Recreation Coordinator Taylor provided an update of the Summer Day Camp Program. She stated that the program was a huge success this year. The staff was the strongest the program has ever had. The program brought in \$58,974 this year. The average children per week was 51. There were increases in cost due to transportation. Due to there not being a pool this summer, children were transported to the Plunge once a week. The total expenses were \$42,000 which resulted in a revenue of \$16,000.

7. INFORMATION ONLY – Summer Soccer Program:

Recreation Coordinator Cuevas provided an update on the Summer Soccer Program. The program had a total of 559 participants and 49 youth teams. There is a total of 8 co-ed adult teams and 6 men teams.

8. INFORMATION ONLY – PFMD and LLMD

Parks and Recreation Director Glick informed the Commission that the Parks and Recreation Department has taken over the PFMD/LLMD districts from Public Works. Superintendent Ray Greenlee has also been involved. There has been some challenges with the districts that staff is trying to work through.

9. INFORMATION ONLY – Fall / Winter Events

Recreation Coordinator Taylor provided information on the upcoming fall and winter events. The Hangout is being held on October 19th for the 7th and 8th graders. The annual Veteran's parade is Monday, November 11th. It is free to enter and participate in the parade. Fall family campout is a new event being held on October 25th at Circle T Ranch. This event is for the whole family. The kids will be able to ride horses and families will paint a pumpkin together. Soccer Thanksgiving camp is 3 days long. Community Thanksgiving dinner is moving to the Recreation Center on Thanksgiving Day. Breakfast with Santa is December 8th. Sweets for Seniors is December 15th hosted by the American Legion. Winter Camp is held for 3 weeks. Summer day camp staff will return to work for winter camp. Red Ribbon Celebration is October 28th at Lions Park.

10. INFORMATION ONLY – Valley Pure / Train Depot

Parks and Recreation Director Glick informed the Commission of Valley Pure leasing the Train Depot. There has been discussions to move the Skate Park and Splash pad. There was a public hearing on this item.

11. INFORMATION ONLY – KCAO Contract Update

Parks and Recreation Director Glick stated that many meetings have been held with KCAO. KCAO's 10 year agreement is expiring. They lease 7,300 square feet for food distribution throughout the County. They currently pay \$1 per year. The Recreation department is looking to expand. A proposal to change the agreement will be on the next City Council agenda. The proposal will be to change the lease amount to \$300 per month.

12. INFORMATION ONLY – City Proteus Workers

Parks and Recreation Director Glick informed the Commission that as of July 1st Parks, Golf Course, and LLMD has lost all Proteus workers. These were state funded workers that the City did not have to pay for. The Parks division lost 7 workers, Golf Course lost 6 workers, and LLMD districts lost 5 workers.

13. INFORMATION ONLY – Proposition 68 Update

Parks and Recreation Director Glick stated that grants for Prop 168 were submitted for Heritage Park and Little League Facility in August. Results for the grant will not be released until November. The funding cycle will repeat in January.

14. COMMISSIONER REPORTS AND REQUESTS:

Commissioner Escalera stated that he read on social media that someone was smoking at the parks. He will be going out to walk the parks.

Commissioner Jordan stated that she enjoyed the 4th of the July run and renaming ceremony. She also attended the time capsule opening at Heritage Park.

Chairperson Rossi followed up on the status of lockers in the Recreation Center.


