Your utility bill from the City includes charges for water, sewer, and refuse, which are due upon presentation and delinquent after 15 days. Effective July 1, 2008, a 10% penalty is charged on all delinquent accounts.

**DELINQUENT UTILITY FEES – NOTIFICATION OF LANDOWNER**

Lemoore Municipal Code 7-7A-10 states the owner or owners of any parcel of real property together with any and all occupants of such real property shall be jointly liable for all charges incurred by reason of the use of said water service by any and all occupants of such real property.

**If you are a tenant renting a home or a commercial building, the City may, in its sole discretion, notify the owner of the property if your account becomes delinquent.**

**You MAY NOT.....**

Water between 10:00am and 7:00pm on designated days.

Use water outside on Monday, Thursday or Friday.

Leave open hoses for irrigation unattended; willfully or negligently waste water in any manner.

Violations of water usage will result in a fee added to your utility bill; further violations will result in additional fees and flow restrictors installed.

Permits are required to drain pools and can be obtained through Lemoore Public Works department.

**AUTOMATED TRASH COLLECTION, 559-924-6744 Division of Solid Waste**

Containers should be out the ***night before*** your scheduled pick up, as crews start at 5:00am. Lids must be closed.

Containers must be removed from the curb on the same day they are emptied.
