Proposed Motion:

No formal motion is required at this time. Staff requests that the City Council discuss a new ordinance that will create an entertainment district downtown.

Background:

The establishment of the Lemoore Downtown Social District represents a transformative opportunity to evolve our historic corridor from a transactional commercial center into a vibrant, "stay-and-stroll" destination. By leveraging the new authorities granted under California Senate Bill 969, this ordinance removes the regulatory barriers that currently isolate patrons inside individual establishments, instead allowing the energy of our restaurants and breweries to spill out onto the street. This model, successfully deployed in peer cities across the state, creates an immediate economic multiplier effect; visitors who are encouraged to linger with a beverage in hand are statistically more likely to browse retail storefronts, attend community events, and extend the duration of their downtown visits, directly benefiting our local merchant community.

Beyond the economic metrics, this initiative serves as a strategic investment in Lemoore's social infrastructure and regional competitiveness. As neighboring communities in the Central Valley modernize their entertainment offerings, creating a safe, designated environment for social consumption ensures that Lemoore remains a premier choice for

dining and leisure rather than losing tourism revenue to Hanford or Visalia. This ordinance is carefully structured to prioritize public safety through strict boundary enforcement and uniform vessel requirements, offering the City a controlled pilot program that balances nightlife vitality with community standards. Approving this zone signals a commitment to a modern, adaptive downtown that fosters community connection and ensures our historic district thrives for generations to come.
