Measure S is a local voter-approved sales tax initiative, approved by the residents of Lemoore to provide a reliable source of funding for essential city services including public safety, infrastructure improvements, and community development.

Pursuant to the Measure S Ordinance and associated oversight requirements, the City receives monthly disbursements from the California Department of Tax and Fee Administration (CDTFA), based on local sales tax collection.

**Financial Consideration(s):**

The City of Lemoore has received a total Measure S disbursement of \$1,234,350 for the reporting period of July through October 2025. This disbursement of Measure S funds positively impacts the City's General Fund and allows the City to continue providing vital services to the community. These funds are restricted to uses outlined in the original

Measure S ballot language and are monitored through internal controls and oversight processes.
