## DUMPSTER RENTAL RULES

1. Dumpsters are rented for 30 days at a time. When your rental period is over City Refuse Workers will pick up the dumpster. If the dumpster is needed for a longer period of time, the renter must pay another \$90 fee at Finance Department 711 W. Cinnamon Drive.

Please be aware of when your 30-day rental expires! You will **NOT** receive a call and you can incur extra charges if your dumpster is not on the curb and ready at pick up time.

2. When your dumpster is full and needs to be emptied or when you are finished with the dumpster and it needs to be picked up, please call the City Corporation Yard at 924-6744. The dumpster will be emptied or brought in as soon as time permits.
3. On scheduled pick up or empty days please move your dumpster to the CURB and make sure it is readily accessible without any obstructions such as parked cars. Dumpsters must **NOT** be left on the street.
4. **THE FOLLOWING ITEMS CAN NOT BE PUT IN DUMPSTER!**
  - Refrigerators, freezers, and air conditioners (due to the Freon in them)
  - Tires
  - No dirt, sod, rocks, brick, cement or shingles. When these items are put into a dumpster, the dumpster becomes too heavy for the truck to lift and the hydraulics on the truck get damaged. If you put these items in the dumpster and it is too heavy and requires us to use a backhoe or other pieces of equipment to lift or remove the dumpster, you will be charged for the rental of the piece of equipment as well as whatever manpower is involved to empty it. Cement is accepted by Bush Construction (584-1575) and Gomes Excavation (583-0236). They require a 24 hour notice before dumping.
  - No hazardous waste: paint, cleaners, pesticides, oils, coolants, etc. **hazardous waste items must be taken to the Hazardous Waste site at Kings Waste and Recycling Authority, 7803 E. Hanford-Armona Road in Hanford, they can be reached at 583-8829.**
